ARTICLES OF INCORPORATION

NEW CORPORATION

THE UNDERSIGNED, DESIRING TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF KANSAS, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION. THIS SHALL BE A NON-PROFIT CORPORATION.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE THE NORTHEAST COMANCHE TRIBE, INC.

ARTICLE II

THE PRINCIPAL PLACE OF BUSINESS OF THE CORPORATION SHALL BE 117 Gunsmoke, DODGE CITY, KS, 67801.

ARTICLE III

THE PURPOSE OF THIS NON-PROFIT CORPORATION SHALL BE THE TRANSACTION OF ANY AND ALL LAWFUL BUSINESS FOR WHICH CORPORATION MAY BE INCORPORATED UNDER THE LAWS OF THE STATE OF KANSAS.

THE INITIAL BUSINESS OF THE CORPORATION SHALL BE TO CONDUCT AVIATION ORIENTED EDUCATIONAL, CHARITABLE AND/OR SCIENTIFIC ACTIVITIES AND TO PROMOTE GOOD MAINTENANCE OF, FLIGHT SAFETY IN, AND THE FLYING ENJOYMENT OF PIPER COMANCHE AIRCRAFT AND TO FURTHER A SPIRIT OF COMRADESHIP AMONGST MEMBERS OF THE INTERNATIONAL COMANCHE SOCIETY THROUGH AVIATION ORIENTED SOCIAL ACTIVITIES OF ITS MEMBERS.

ARTICLE IV

THE FISCAL YEAR OF THE CORPORATION SHALL BE JANUARY 1 THROUGH DECEMBER 31 OF EACH YEAR.

ARTICLE V

THE NUMBER OF PERSONS TO SERVE ON THE BOARD OF DIRECTORS SHALL BE NOT LESS THAN THREE OR THAT GREATER NUMBER FIXED FROM TIME TO TIME BY THE BY LAWS OF THE CORPORATION. THE FOLLOWING PERSONS SHALL CONSTITUTE THE INITIAL BOARD OF DIRECTORS, TO SERVE UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.

UPON DISSOLUTION OF THIS CORPORATION, ALL ASSETS OF THIS CORPORATION SHALL BE TRANSFERRED TO ANOTHER NON-PROFIT CORPORATION, DETERMINED IN ACCORDANCE WITH THE NORTHEAST COMANCHE TRIBE BYLAWS, AND WHICH IS QUALIFIED AS A CHARITABLE CORPORATION UNDER SECTION 501(C)3 OF THE INTERNAL REVENUE CODE OF 1954 AS AMENDED FROM TIME TO TIME;

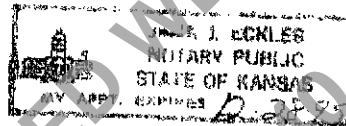
