We are sending this letter to inform you of the resolution, **passed last fall by Tribe officers, barring you from attending any future Tribe fly-ins.**

The officers of ICS-NE have received numerous complaints regarding your behavior at Northeast fly-ins and meetings over the past year. Given the nature of your past behavior, it seems likely that you will continue to show up and disrupt our Tribe's fly-ins, administrative meetings, and safety meetings. This clearly contravenes the stated purposes of the organization as listed in the Northeast Comanche Tribe, Inc Articles of Incorporation, to wit: *"to promote good maintenance of, flight safety in, and the flying enjoyment of Comanche aircraft and to further the **spirit of comradeship among members** of the International Comanche Society through aviation oriented social activities of its members."*

Some specific complaints and actions include the following:

1. The Tribe held a conference call on February 16, 2018. Mr. Shiloh's interference with the meeting (which included monopolizing the speaking time, bullying, and shouting down other members, interfering with their right to speak) **caused the meeting to be cut short before all the planned topics were covered.**
2. At the Tribe's fly-in at Lancaster, PA on Oct 20, 2018, Mr. Shiloh's interference with the meeting prevented the **Tribe from completing the planned safety activity** (creating a customized fuel tank dipstick).
3. At the Tribe's fly-in at Georgetown, DE on Nov 17, 2018, Mr. Shiloh's interference with the meeting prevented the **Tribe from holding the planned safety activity** (lecture from Eric Sachs on medical certificates).
4. The officers of the northeast Tribe received a number of verbal and written complaints from Tribe members who attended the above three meetings, regarding Mr. Shiloh's behavior and interference, requesting that the officers take action to stop similar occurrences from happening at future meetings.
5. At the above meetings, Mr. Shiloh made demonstrably false statements about the Northeast Tribe and its officers, **impugning the integrity of the officers and damaging their reputations within the community.**
6. The Tribe officers met on Nov 17 to discuss the complaints from the members and how to act. After careful consideration, the officers concluded that the primary concern with Shiloh's attendance at Northeast Tribe fly-ins and meetings is that his presence and actions **cause emotional distress to members attending.** The type and intensity of disturbance created by Mr. Shiloh caused some attendees sufficient emotional distress that it could affect their safe flight operation on the way home (IMSAFE). Various possible actions were considered, including revoking Mr. Shiloh's membership in the Northeast Tribe. It seemed prudent, as a first step, to suspend Mr. Shiloh's fly-in privileges for a period of time. It was therefore decided to bar him from attending fly-ins for 2019. Possible membership revocation was also discussed. Such action will be held in reserve as a possible secondary measure, to be taken in the case that Mr. Shiloh does not comply with the terms of the fly-in ban.

Therefore it is the decision of the officers of the Corporation that Avraham Shiloh be barred from attendance at any 2019 fly-in of the Northeast Comanche Tribe Inc.
