Pete,

1. **Apparently, some candidates have changed their minds about running for various tribe positions. However, I did not.** Why did you remove my name from the Secretary/Scribe position without consulting me?
2. If the voting is done on YOUR website, the fact that the ballots will be forwarded to an independent auditor (who is chosen solely by you) is useless, and is simply window-dressing. You would be able to forward any data you want. **The whole point here is that the voting must be conducted on an independent site, one to which no candidate has access, and which must specifically preclude you or any candidate from being able to tamper with the ballots.**
3. Please specify the times/dates that voting will be open.

Finally, I again hereby formally object to any voting process in which you (or any candidate) has access to the ballots at any time.
