Dear Angelo,

The netribeelections@gmail.com address belongs to CJ Stumpf's boyfriend, Les Thomas, who is administering the (dubious) election in which CJ Stump is a candidate. They are part of the (rogue) group claiming to be the tribe officers. They are sanctioned neither by the official ICS Northeast Tribe (Northeast Comanche Tribe, Inc.), nor by the International Comanche Society (ICS). They posted my name on their election ballot against my will. The real tribe elections occurred in March. The rogue group had petitioned the Michigan Circuit Court to disqualify the March election. The court rejected their petition and ordered them to turn over the tribe funds. When they refused, they were scheduled for a contempt of court hearing. At that time, the judge also ordered that they cease using our database to contact our members. Unfortunately, they continue to use it.
